Directs authority to submit findings to interim committees of Legislative Assembly related to health not later than September 15, 2024.] Requires local planning committees for alcohol and drug prevention and treatment services to coordinate with local Behavioral Health Resource Networks. Establishes policy of state to encourage treatment and recovery for people struggling with substance use. Removes four percent cap on amounts from Drug Treatment and Recovery Services Fund that Oregon Health Authority may use for administrative expenses to administer provisions of Ballot Measure 110 (2020).
